The undersigned Owner hereby agrees to and acknowledges the following:

- ALL VEHICLES ARE STORED AT THE OWNER'S SOLE RISK. Ashuelot Park, LLC does not maintain
 insurance covering damage to any stored vehicle and shall not be responsible for damages to the
 vehicle or any personal property stored in the vehicle while at Ashuelot Park, LLC's facility (the
 "Facility").
- Owner is responsible, at Owner's sole cost and expense, for maintaining insurance to cover any
 damage to the vehicle and any property in the vehicle while in storage at the Facility and to cover
 Owner's liability for damages to others or their property caused by Owner's vehicle while at the
 Facility. Owner represents that he/she has contacted his/her insurance carrier and secured such
 insurance coverage. If requested by Ashuelot Park, LLC at any time during the storage period,
 Owner shall provide proof of such insurance.
- All vehicles must be stored with batteries disconnected.
- Owner shall not, at any time, store any dangerous or illegal materials or substances within the vehicle while in storage at the Facility.
- Keys must be left in the vehicle unless otherwise agreed by Ashuelot Park, LLC and noted above.
